3. Manager Report

a. Surveillance and Treatments – larval and adult surveillance are ongoing. Still not seeing many adult mosquitoes in my traps. The larvae are showing up at English Boom with the recent high tides and have been treated.

- o <u>Mosquito Pools</u> County Breakdown: Franklin County − 1, Grant County − 26, Yakima County −1, Benton County − 4
- **Birds** County breakdown: Benton County 2
- o Human Cases County breakdown: Benton County 1
- c. Storm drains in Camaloch and at Terry's Corner have been treated with larvicide. Probably about 98% of the storm drains had standing water.
- d. I'm always looking for new trapping sites and I like to place them in safe places, so I'd like to place traps at or near Dave, Tim, and Theresa's homes if that's ok? I try to trap at least twice a week depending on other workload. I set the traps in late afternoon and pick them up the next morning. I also have traps that can be left at the property for 2-3 weeks; these traps run on propane and are a little bigger than the surveillance traps. I usually put these out at places that are having adult mosquito problems but I haven't had any calls since April.
